

County Physician Autopsy Record Book, 1913-1919

The County Physician Autopsy Record Book was created by the County Physician and contains autopsy reports which include descriptions of bodies, injuries, organs, tissues, pathological diagnoses, and causes of death. Corpses generally are named, but sometimes they are unknown. Attending physicians present are listed, as well as undertaking parlors.
