4.1	Proposed Hire Report / Incentive Plans - \$3,000 and Under / Weekly Reclassification Report	The Proposed Hire Report is a weekly report of all active job postings that were opened in the prior week, to recruit and hire new SLCo employees. The Incentive Plan is a list of all recently approved incentive plans that total \$3,000 or less. The Weekly Reclassification Report is a report of all job reclassifications that were completed in the last week.
4.2	Budget Adjustment: Utah State Indigent Defense Commission (IDC) has awarded \$73,160 grant to Salt Lake County Indigent Legal Services.	Utah State Indigent Defense Commission (IDC) has awarded a grant \$73,160 to Salt Lake County Indigent Legal Services. This request is to pass through the grant funds \$30K to the provider LDA and \$43,160 to the provider UJDA. It is a one-time budget neutral adjustment with no impact on County funding. This request is also to correct one technical budget coding issue.
4.3	Budget Adjustment: Indigent Legal Services requests \$250,000 one- time to fund a contract with a private defense attorney to replace the Salt Lake Legal Defender Association (LDA) for an aggravated murder case due to a conflict of interest	The Salt Lake Legal Defenders Association (LDA), the county's primary adult criminal defense services provider, has a material conflict of interest in the aggravated murder case State v. Sandoval because they represent a co-defendant. The court has therefor ordered that the county provide alternate representation. This is a one-time request to fund the hiring of a private attorney to represent Mr. Sandoval through trial or other resolution of the case.

4.4	Budget Adjustment: The Salt Lake County Children's Justice Center requests a 12-month time-limited Forensic Interviewer position. This position will be funded with a new grant from the National Children's Alliance (NCA) in the amount of \$30,000 and \$43,948.17 carried over from 2023 NCA award of \$50,000	The Salt Lake County Children's Justice Center has received a new award of funds from the National Children's Alliance (NCA) in the amount of \$30,000 for a Forensic Interviewer TL position. The 2023 NCA award was \$50,000 for a Victim Services Coordinator TL position however we were unable to hire due to recruitment and salary issues. Since that time, funding for the Victim Services Coordinator TL has been shifted to the State of Utah Base contract funding that was increased as of 7/1/23. Of the \$50,000 award, \$43,948.17 has been allowed to carryover to 2024 to support the hiring of the additional Forensic Interviewer TL. This provides us with \$73,948.17 in funding for this position for 12 months of 2024. Due to the delay that will occur for the hiring process we will most likely use this funding for 10 months. The addition of this position will allow us to fully staff both locations of the CJC and increase services to child victims of crime. This request is for an additional time-limited Forensic Interviewer position
4.5	Budget Adjustment: Mayor's Finance requests an additional \$8,101 to cover PaymentWorks rate increase. This increase will be offset by an increase in P-card rebate revenue, and the new EarlyPay PaymentWorks program.	We need to adjust the 2024 PaymentWorks expense budget to match the Carahsoft PaymentWorks contract. This expense increase is offset by an increase in P-card rebate revenue, and the new EarlyPay PaymentWorks program, which makes this adjustment budget neutral.
4.6	Budget Adjustment: This is a post year-end budget adjustment for 2023. Facilities Services requests an appropriation unit shift of \$575,000 from personnel to building maintenance pass-through account. This was due to increased material costs and the department being seriously understaffed and having had to outsource more of their work	Facilities Services is requesting a one-time appropriation unit shift to the facilities pass thru. Due to increase costs in maintenance and changes to maintenance contracts we need to increase the budget to pay the remaining 2023 invoices.

After the Plat and Deeds were executed by the County pursuant to this authorization, these documents were returned to obtain the signature of one final property owner. This final property owner ultimately declined to participate in the subdivision, and it was determined to record the Plat and Deeds without this property owner's participation. The Plat and Deeds were modified to reflect the withdrawal of this property owner from participation in the subdivision; however, the revised documents were not resubmitted to other Consideration of a Resolution of property owners for ratification, including the County, before they were submitted to the Salt Lake County Recorder's Office to be recorded. The the Salt Lake County Council Ratifying the Camp Kearns Plat containing the modification was recorded on October 24, 2023, as Subdivision Plat and Related Quit Entry No. 14166740, in Book 2023P at Page 209 in the Salt Lake County Claim Deeds Recorded on October Recorder's Office. A copy of this Plat is attached hereto as Exhibit A. 24, 2023 The Deeds containing the modifications were recorded on October 24, 2023, as Entry Nos. 14166858, 14166859, 14166860, 14166861, 14166862, & 14166863, in the Salt Lake County Recorder's Office. Copies of these Deeds are attached as Exhibit B. The recording of the modified Plat and Deeds accomplished what the County intended to accomplish with respect to the other participating property owners and the result is acceptable to the County. The participating property owners have each signed affidavits ratifying the recording of the modified Plat and Deeds, and affidavits from the County's representatives who originally signed the Plat and Deeds have also been prepared and are attached hereto as Exhibit C. Therefore, it has been determined that the best interests of the County and the general public will be served by ratifying the Plat and the Deeds as recorded and authorizing the execution of the affidavits attached as Exhibit C
