3.1	Proposed Hire Report / Weekly Reclassifications Report / Incentive Plans	The Proposed Hire Report is a weekly report of active job postings to recruit and hire new SLCO employees. A spreadsheet of all completed job reclassifications and a list of all incentive plans that were signed that week.
3.2	Budget Adjustment: Capital Improvement's Request for New Capital Project and Transfer of \$100,000 from Under-expend for Election Island in the South Building Parking Lot	This project will add an island to the parking area of the South Building. This will be a drive up and drop off island for voting ballots. To improve the safety and speed in which pedestrians drop off ballots. Additional funding will be from completed projects under expend.
3.3	Budget Adjustment: Economic Development's Request to Appropriate \$1,500,000 in Revenue and Expense related to EPA Brownfields Revolving Loan Fund for Environment Remediation Loans	Salt Lake County has been awarded a total of \$1,950,000 in EPA Brownfields funding to seed a Revolving Loan Fund offering zero- and very low-interest loans to clean up environmental contamination. The RLF Coalition board has recently approved issuing three loans of \$500,000 each, for a total of \$1,500,000. These loans are anticipated to be disbursed in March 2022, April 2022, and June 2022. The loans are secured by commercial properties under redevelopment and will be paid back within 2- and 3-year terms. The EPA requires the County to lend the money to borrowers, then request reimbursement from the EPA for the loan amounts. Thus, this budget request is revenue neutral. The County will lend to the borrowers and be reimbursed by the EPA in the same amounts.

Construction bids have been opened, and the amounts exceed the project's available budget. Parks & Recreation requests this adjustment to increase the project's expense budget to begin construction by increasing the budget to account for a new grant, by unassigning previously received grant revenues that have fallen to fund balance, and by transferring available budget from substantially complete projects.

The Corporation of the Episcopal Church in Utah is a non-profit in Salt Lake County and operates a summer youth camp known as Camp Tuttle. Salt Lake County owns a parcel located at 7655 Big Cottonwood Road, described in the License to Use Property in Attachment A to this resolution. The Salt Lake County Council desires to allow Episcopal Church non-exclusive access to use a portion of the Property as described in the License agreement in Attachment A.
