3.1	Proposed Hire Report / Incentive Plans under \$3,000 / Weekly Reclassification Report	Weekly report of active job postings to recruit and hire new SLCO employees and a weekly report of any completed job reclassifications.
3.2	Budget Adjustment: Office of Regional Development's Request for \$853,574 in ARPA Funding for the Salt Lake Center Of Opportunity Partnership (CO-OP) Project	ARPA- Salt Lake Center Of Opportunity Partnership (CO-OP) will provide technical assistance, counseling, and other services to assist businesses from socioeconomically disadvantaged communities. CO-OP will use ARPA funding to launch a long-term initiative to increase economic opportunity in Salt Lake County by increasing the availability and connection to resources that will help these businesses thrive. 3.3	Budget Adjustment: Office of Regional Development's Request for \$6,283,613 in ARPA Funding for the Workforce Inclusion and Successful Employment (WISE) Program	The Workforce Inclusion and Successful Employment (WISE) Program funds non-County organizations that help lower-income communities get higher-paying jobs. WISE pays for training institutions to provide resource navigation, outreach, advising, career coaching, and mental health counseling. It also pays for community-based organizations to provide holistic support that connects people to jobs. The goal of WISE is to demonstrate a positive net tax impact, where program expenses are offset by increased tax revenue and decreased benefits expenses. The Salt Lake County Council approved \$10m in American Rescue Plan Act funding for WISE on April 5. That amount will fund WISE through 2026. This budget adjustment recognizes the necessary funding for 2022.
3.4	Budget Adjustment: Parks and Recreation's Request for \$3,476,000 for Park Irrigation Improvements	Council approved this deferred maintenance project for park irrigation improvements on March 1, 2022. This request appropriates funding for phase 1. Salt Lake County Parks and Recreation will utilize this funding to review and design existing irrigation infrastructure to enhance smart water management efforts. The redesigns will more effectively conserve water, a precious commodity.

3.5	Budget Adjustment: Assessor Request for \$283,229 for Market Adjustment that was Approved November 2021	Near the end of 2021 Council approved \$226,167 salary and \$57,062 benefits for a total of \$283,229 additional funds for salary adjustments in the Assessor's Office. This should have been included in our 2022 budget but was not included in error. This is to add the approved funds to our budget.
3.6	Budget Adjustment: Solid Waste Management's Request for \$70,000 from the Restricted Capital Improvements Account for the Perimeter Road Capital Project	The current total budget for the Perimeter Road project (Phase 1-3) is \$990,000. The new estimated cost is \$1,060,000 due to the current economic outlook. Increasing the budget by \$70,000. This is a balance sheet item and funding will come from the restricted cash account for capital improvements.
3.7	Budget Adjustment: Parks and Recreation's Requested to Use \$21,921 in Restrict Fund Balance for a New Harmony Park Capital Project	In a settlement agreement with an adjacent property owner at Harmony Park, money was set aside in a restricted account for future park improvements. Parks & Recreation would like to move forward on those improvements by converting one of two ball diamonds in the park to a multipurpose field to serve other programming such as soccer, lacrosse, rugby, and passive recreational users. This ball diamond has not been used for recreation programming for several years and believe the best use of the area is to convert the space to serve multiple recreational activities. These funds will help serve more park users, while still preserving a ball diamond within Harmony Park for recreational games and programming. The one-time appropriation of these funds will be offset by an unassignment of General Fund restricted funds that have been assigned for Harmony Park improvements (on myfin Journal 20FIFR 12/30/2020 Line
3.8	Budget Adjustment: Parks and Recreation's Request to Transfer \$115,000 from the Capital Renewal/Replacement Capital Project to the Wheeler Farm Outdoor Education Center Capital Project	5), the net effect to the General Fund will be \$0 Transfer funding from underspent bond capital renewal and replacement projects to Wheeler Farm Education Center to finish up purchasing signage, storage shelving, security cameras, and FF&E. No new county dollars are requested.

Providence Towne Center LLC owns property in Salt Lake County, Utah, Parcel No. 33-06-100-045, with the address of 4585 West 13440 South, Riverton, Utah 84123. On September 8, 1992, the Hamilton's Homestead Subdivision Plat was recorded with a hand-written note identifying the "ROSE CREEK MAINTENANCE CHANNEL 40' EASEMENT 20' EACH SIDE OF [center line] EXCEPTING THAT PORTION OUTSIDE OF SUBD. BOUNDARY LINE" and the location of the Easement hand-drawn on the Plat. The existing channel of Rose Creek has been realigned and no longer passes through the Property. Salt Lake County Flood Control has reviewed the change to the Rose Creek channel and has determined that there is no longer any need to retain this Easement. Owner has asked the County to release and quit-claim any interest it may have in the Easement.

A Resolution of the Salt Lake County Council Declaring Surplus Real Property and Approving the Conveyance of the Same By Quit-Claim Deed to EOS at Parkside, LLC Salt Lake County owns a parcel of real property, located approximately at 210 South Edison Street, Salt Lake City, Utah, identified as Tax Id. No. 16-06-154-031, which was struck off to the County after the tax sale in 1987. EOS AT PARKSIDE, LLC, has offered in writing to purchase the Property from the County for eight hundred three and 24/100 dollars (\$803.24), which amount has been approved by the Salt Lake County Real Estate Section as fair market value. This offer is in the form of a Tax Sale Property Purchase attached hereto as Exhibit A. The County has determined that the Property is not in public use. Proceeds from the sale of the Property will be distributed in accordance with Section 59-2-1351.5 of the Utah Code

A Resolution of the Salt Lake County Council Approving a New Lease Between Salt Lake County and Cottonwood Heights Parks and Recreation Service Area

Salt Lake County owns a parcel of real property in Cottonwood Heights, Utah, located at 7500 South 2700 East. Since 1978, the County has leased only a portion of Property to Cotton Wood Heights Parks and Recreation Service Area. The Service Area has constructed portions of an outdoor swimming pool, an indoor ice-skating rink, and additional recreational facilities on the Leased Area pursuant to the terms of previous written leases with the County. The County and the Service Area entered the currently effective lease for the Leased area on June 6, 2006. The 2006 Lease had an initial ten-year term that was extended on October 7, 2015, for an additional ten year-term. The Service Area would like to expand the Leased Area to include all the Property except for the portion currently occupied by an emergency response substation used by the Unified Police Department. The County wishes to lease the New Leased Area to the Service Area pursuant to the terms of the Lease, attached as Exhibit A. Upon execution of the New Lease, the 2006 Lease will terminate and be of no further effect. The New Lease has an initial ten-years term with the option to extend the term for 2 additional ten years. As in the 2006 Lease, the Service Area will pay a nominal consideration of \$1.00 per year for under the New Lease.

A Resolution of the Salt Lake County Council Approving and Authorizing the Mayor to Execute an Easement Grant to Draper Irrigation Company Salt Lake County owns a parcel of real property located 1283 East Mike Weir Dr. in Draper, Utah, where the clubhouse for the South Mountain Golf Course. The County has leased a portion of the Property to Siempre, LLC that allows Siempre to construct a new event center adjacent to the clubhouse. A 20-foot wide perpetual easement across the property is necessary to allow Draper Irrigation Company to construct and repair an underground culinary water pipeline to provide water services to the Event Center. The installation and connection to Draper Irrigation's Water Facilities constitutes fair and adequate consideration for the grant of said easement, and no other fee shall be required for the easement because of the benefit the Water Facilities will provide to the Event Center on the County Property. The County and Draper Irrigation have prepared an Easement Grant, attached as Exhibit A, wherein the County grants the requested easement across a portion of the County Property to Draper Irrigation for the construction, maintenance, and repair of the Water Facilities.
